These documents may also show calls to a fax broadcaster, showing that Heysek had direct involvement in authorizing the illegal fax transmissions.

4. These documents are material to the issues involved in this case for the following reasons:  
The documents should establish that Heysek is a director of WSP and responsible for the sending the faxes. The time period chosen is the month prior to the faxes being sent (when presumably the promotion was being formulated and relationships with the fax broadcaster were put in place), and the months that the faxes were sent.
