For the record, Sterling ACS, Ltd. is a financial and corporate service provider. We don't register domain names. I might add that we didn't even know how to do so, until this unpleasantness arose. Sterling Trust (Anguilla), Ltd. is a fully licenced trust company, also not in the business of faxing or e-mailing, or supporting those that do so.

We have learned how to find out who is falsely posting our information, however, thanks to this episode. We have researched each of the names you gave Mr. Russo, and those we understood we were being accused of somehow being surreptitiously involved.

Registrant is SI Holdings, LLC in Freeman, MO, not any Sterling entity. We have contacted them and demanded that the information on this site regarding our company be removed. They are doing so, as they have verified that the information was false by visiting the registered site at tucows.com, which I might suggest as a prudent course.

winningstockpicks.net-

Registrant is TUCOWS INC. When running a "Whois" search (I must thank you for making us learn this new skill), the information shows Worldwide Picks LTD, Norfolk House, Nassau, Nassau BS, and the phone number

is 516.977.7571. The contact is <u>admin@winningstockpicks.net</u>. It would not let me print or copy the page, but you may wish to visit tucows.com yourself to verify, and contact them.

stockarena.com-

Registrant is Stock Arena, LLC in Shakopee, MN. Phone is 612.207.3733, and the contact is Steven Path. I was given this information when we called to query ownership and registration of the site posting our company (with my name) as the contact for the site. The information on this company came from Network Solutions.com.

Our businesses are; incorporating companies in the Bahamas, and managing trust activities in Anguilla. We are not in the business you suggest, nor do we support or condone such. Your letter proposes that we are attempting to hide something or being obstinate, indicating guilt. If the facts above (and your subsequent research of them) does not deter you from such thinking, then I suggest you proceed with your legal action. You'll find our legal system quite interesting, and refreshing in many ways compared to America.

We have spent an enormous amount of time researching these issues prior to responding, as well as our U.S. attorney's time (which is not inexpensive), and must draw the line at this juncture. Our company has no control over who pulls our name off the Financial Services website and uses it, but those doing so in this instance have been informed and appear to have made the proper corrections.

Our contact information is posted publicly (and proudly) on the Financial Services directory, so you have the information you need to proceed against us or any entities you suggest we may control, should this information be found deficient in your opinion.

Having received 7 unsolicited faxes and 53 unsolicited e-mails just today, it would be difficult for us to be hostile to your efforts, however, and I personally wish you luck in curbing this abuse.
